# Joint-Stock Company "Liepājas Metalurgs" Management Statement Regarding the Financial Statements for 9 months of 2009.

The Company's loss from business activities in the reporting period was 4.88 mill LVL (EUR 6.9 mill.), which was a profit of 8.9 LVL (EUR 12.7 mill.) in 9 months of the year 2009.

The Net Turnover in the reporting period was 116.5 million LVL (EUR 165.8 mill.), and it was 224.4 million LVL (EUR 319.3 mill.) in 9 months of the year 2009.

The decrease of net turnover and profit was primarily related to the economic and financial crisis and the fact that the reduction of sale prices was greater than reduction in the materials purchase price, the production volume in 9 month of the year, however, was 0.3% greater compared to the same period last year.

The Company invested LVL 0.9 mill. (EUR 1.3 mill.) in its development during the reporting period. JSC "Liepājas Metalurgs" continue the activities concerning the steel melting production practice and related to its modernization program coordination and financing.
