16.2 Accounting policies

Financial statements for the 6 months ended 30 June 2008 are prepared in accordance with International Financial Reporting Standards (hereinafter – IFRS).

Certain figures of financial statements for the 6 months ended 30 June 2007 were reclassified in order to correctly reflect the comparative information of 30 June 2008.

16.3 Revenues and expenses

During the Ist half of 2008, the Group earned LTL 18,7 million in agricultural activity evenues (2007 – LTL 15,7 million). The significant increase as compared to previous year is due to directed investments into subsidiary companies milk production facilities and increase in average raw milk price.

The operating expenses totalled LTL 6.174 thousand (2007: LTL 2.692 thousand). The operating expenses increase significantly because rapid expansion of the Group started – a strong management team was formed, as well as significant consulting and legal expenses incured.

Over the 6 month period ended 30 June 2007, a LTL 25 598 thousand profit from revaluation of investment property was received. According to the International Financial Reporting Standards, after the acquisition of Žemės vystymo fondas group, all the investment property, i.e. agricultural land owned, had to be reevaluated. No such revaluation was made in 2008, as the management plans to carry it out in the end of the year.

During Ist half of 2007, the negative goodwill written off amounted to LTL 3,7 million due to acquisition of Žemės vystymo fondas group. No acquisitions were made during 2008, but two preliminary share purchase agreements were signed.

Financing costs almost doubled in 2008 as compared to 2007, as the rapid expansion of the Group (land acquisitions, investment projects, modernisation) are being financed by borrowings.

16.4 Balance sheet

Fixed assets of the Group over the 6 month period did not increase significantly. The increase is mainly due to start of investment programme, according to which nitrate systems will be established in agricultural entities, silo storages built, and certain farms reconstructed.

The biological assets of the Group over 6 month period increased by 61 per cent due to investments to increase the milking cows herd and expenditure for crop growing business made.

Over the first half of the year, the Group issued a new 6.143 thousand shares emission. The attracted funds (LTL 28,4 million) will be used for financing of Group's investment programme.

Groups long-term financial liabilities increased by LTL 20 million up to LTL 115 million due to long-term credit with DnB Nord regarding land financing, 2 new additional bonds emissions issued and one refinanced. The attracted capital will be used for financing of Group expansion.

Accounts and other payables amount increased almost by 100 per cent, as the Groups agricultural entities started commencing investments into farm modernisation and equipment renewal. Additionally, the acquisitions of fertilisers and pesticides were made.
