Notes to the financial statements

1 General information

AB Klaipėdos Jūrų Krovinių Kompanija (hereinafter "the Company") is a public limited liability company registered in the Republic of Lithuania. The address of its registered office is as follows:

J. Zauerveino Str. 18, Klaipėda Lithuania

The Company is engaged in provision of stevedoring and related services in the seaport of Klaipėda. The Company started its activities in September 1994. Until 31 May 1994 the Company's name was SPĮ Klaipėdos Valstybinis Jūrų Prekybos Uostas. On 3 May 1995 the Company was registered as a public limited liability company. The Company's shares are included in the Baltic Secondary List of Vilnius Stock Exchange.

All the shares of the Company are ordinary shares with the par value of LTL 10 each and were fully paid as of 30 June 2008 and 2007. The share capital did not change in 2007 and 2008. Subsidiaries, joint ventures and associated companies did not hold any shares of the Company as of 30 June 2008 and 2007. The Company did not hold its own shares either.

Company sold 100% of the stocks of subsidiary company JSC "Kroviniu terminalas" in 7 June 2008. The result of subsidiary JSC "Kroviniu terminalas" in period from January to May 2008 is included in the Group consolidated financial statement.

Company had no control in UAB Klasco Ekspedicija and UAB Krantas Forwarding, therefore these companies were not included in the Group's consolidated financial statements.

As of 30 June 2008, the number of employees of the Company was 797 (799 as of 31 December 2007). As of 30 June 2008 the number of employees of the Group was 797 (838 as of 31 December 2007).

2 Form and contents of the financial statements

These financial statements have been prepared in accordance with International Financial Reporting Standards (IFRS) as adopted by the European Union.

The same accounting policies were applied for interim reporting as are applied in the annual financial statements.

The Company's and the Group's functional currency is local currency, Litas (LTL). The amounts shown in these financial statements are also presented in the local currency, Litas. Lithuanian Litas is pegged to EUR at the rate of 3.4528 Litas for 1 EUR, and the exchange rates in relation to other currencies are set daily by the Bank of Lithuania.

JSC Klaipėda Stevedoring Company Interim statement covering the first 6 months of 2008

Klaipėda, 29 August 2008

The interim statement of the Company covering a period of 6 months has been compiled in compliance with the provisions of Article 24 of the Law on Financial Statements of Entities, the provisions of Article 9⁽¹⁾ of the Law on Consolidated Accounts of Entities of the Republic of Lithuania, and in accordance with the procedure set forth in Article 22 of the Law on Securities of the Republic of Lithuania and Article 34 of the Law on Companies of the Republic of Lithuania. The Articles of Association of JSC Klaipėda Stevedoring Company do not stipulate for any additional requirements which should be reflected in a 6-month statement.

1. Objective overview of the status of the group of companies, operations and development, and characterization of the main types of risks and uncertainties encountered

The operations of JSC Klaipėda Stevedoring Company (the parent company) involve port stevedoring operations, cargo warehousing and port towage services. In the market, the company sees other stevedoring companies operating in Klaipėda State Seaport and stevedoring companies operating in the ports of neighbouring foreign countries as its competitors. During the 1st half of 2008 the company handled 4.976 mln. t of cargo, i.e. by 16 per cent more than during the 1st half of 2007, when it handled 4.297 mln. t of cargo. The load of the terminals located in the northern part has increased by 33 per cent this year, whereas the load of the International Ferry Terminal has decreased by 7 per cent, from 1.866 mln. t (2007) to 1.732 mln. t. The decrease of the load of the International Ferry Terminal can be accounted for by the growing prices for ship's fuel, the expansion of the Schengen area, and the general decline in cargo carriage business.

On 9 June 2008, 100% of the shares of the subsidiary company JSC Krovinių terminalas were sold. Other companies, part of the stock capital of which is owned by JSC Klaipėda Stevedoring Company by proprietary right, are engaged in forwarding services and participate in marketing projects. With the aim of satisfying customers' needs in the cargo carriage market, the group of companies is ready to offer a complete range of services covering "door-to-door" delivery of cargo.

2. Analysis of financial and non-financial business operation results of the group of companies; information pertaining to environment and personnel issues

During the 1st half of 2008, the integrated operations of the group of companies included stevedoring operations, cargo warehousing in the port of Klaipėda, cargo forwarding, ship towage and other services related to cargo handling and carriage. During the 1st half of 2008, the turnover from sales of the group of companies amounted to 88,667 thousand Lt. The profit before taxes of the group of companies amount to 11,961 thousand Lt.

On 31 December 2007, JSC Klaipėda Stevedoring Company had 799 employees; on 30 June 2008 there were 797 employees. The number of employees of the group of companies has decreased considerably due to the sale of a subsidiary.

3. References and additional clarifications pertaining to data given in the consolidated financial accounts

There are no additional clarifications.

4. Important events since the end of the previous financial year

- On 14.01.2008 JSC Klaipėda Stevedoring Company informed that in 2007 it handled 9.589 mln. tons of cargo and earned 140 mln. Lt in non-audited revenue.
- On 11.02.2008 JSC Klaipėda Stevedoring Company reported that Geraldas Statulevičius resigned from his position of a Board member as from 10.02.2008.
- On 19.02.2008 JSC Klaipėda Stevedoring Company informed that an ordinary shareholders' meeting is called on 31.03.2008, and announced the agenda of the meeting.
- On 29.02.2008 JSC Klaipėda Stevedoring Company produced non-audited interim consolidated financial statements for 2007.
- On 21.03.2008 and ordinary general shareholders' meeting of JSC Klaipėda Stevedoring Company was held. The venue of the meeting: the registered office of the company at Zauerveino g. 18, Klaipėda.
- On 21.03.2008 JSC Klaipėda Stevedoring Company informed of the resolutions of the shareholders' meeting of 21.03.2008;
 - To approve the conclusion of the audit company regarding the audit of the company's operation results of 2007.
 - To approve the financial statements of 2007.
 - To approve the draft distribution of the profit (loss) of last year: profit (loss) brought forward at the end of 2006 68,715 thousand Lt; net profit (loss) of the accounting financial year 13,514 thousand Lt; the result available for distribution 82,229 thousand Lt; distributed for payment of dividend 23,000 thousand Lt (6,661 thousand EUR; 1.815 Lt (0.525 EUR) per share); profit (loss) brought forward; for annual payments (tantiemes) to members of the Board and the Observing Board, personnel bonuses and other purposes 1,380 thousand Lt; profit (losses) brought forward at the end of 2006 57,849 thousand Lt.
 - o To select and approve ERNST & YOUNG Baltic UAB for the audit of the company in 2008; the said company shall be paid an amount not more than 120,000.00 Lt for its services.
 - To revoke Geraldas Statulevičius, who has applied for resignation, from his position of a Board member.
 - Juozas Benetis has been elected to the Board of the company.
- On 29.05.2008 JSC Klaipeda Stevedoring Company produced the non-audited financial statements and operation results covering the first quarter of the year.
- On 17.06.2008 JSC Klaipėda Stevedoring Company announced that it had sold 100% of the shares
 of its subsidiary JSC Krovinių terminalas.
- On 01.08.2008 JSC Klaipeda Stevedoring Company produced the results of the first half of 2008.

5. Plans and forecasts for the operations of the group of companies

The plans for 2008 include increase of sales by attracting additional cargo flows to JSC Klaipėda Stevedoring Company, further improvement of the work payment system based on the final work results and work efficiency, and renovation of the loading machinery fleet.

6. Information on the research and development activities of the group of companies

In 2008, the company intends to invest a 22 mln. Lt. A number of contracts were signed and design works were started in the 1st half of 2008. A contract was signed for the design works related to the development of the Bulk Fertilizer Terminal and reconstruction of KAS (liquid fertilizer) and ethylene glycol terminal railway wagon discharge station. The design works should be completed in the 1st half of 2008.

Projects at the International ferry Terminal at Quay No. 144 are continued. At present, the detailed plan of the part of the territory next to Quay No. 144 is in the stage of completion, and the environmental impact assessment has been submitted for approval. Contracts were signed for design works of the objects planned next to Quay No. 144, i.e. a cold storage for fruits and vegetables, a cold (deep freezing) storage and a liquid product terminal (Stage 1). The design works should be completed in the 1st half of 2009.

A contract was signed for the design works of the development of infrastructure of the International Ferry Terminal.

In the 1st half of 2008, the construction of the warehouse intended for handling paper and general cargoes (Stage $1-4,000\,\text{m2}$) at the International Ferry Terminal was completed. The construction of the first of the two port tugs is being completed at a Russian shipbuilding yard. The tugboat will make it possible to render towage services to all types of vessels calling at the port of Klaipėda from October this year.

7. The number and nominal value of the shares of the parent company owned by the company itself, its subsidiaries or persons acting on the companies' assignment but in their own name

JSC Klaipėda Stevedoring Company has not acquired it own shares, nor any of its subsidiaries has acquired its shares; likewise no person acting in his own name but on assignment of the parent company or its subsidiary has acquired any shares of JSC Klaipėda Stevedoring Company.

8. When the group of companies uses financial measures and when it is important for the assessment of the assets, the own capital, the obligations, the financial status and the operation results of the group of companies, the aims of financial risk management are disclosed, the measures for insuring the main groups of planned deals are used, to which the accounting of insurance deals is applied, and the scope of the price risk, credit risk, liquidity risk and cash flow risk of the group of companies.
