ACTIVITIES REPORT BY MANAGEMENT BOARD

AS Premia Foods is a food production company, which operates in six markets and is listed in the main list of NASDAQ OMX Tallinn Stock Exchange since 5 May 2010.

The company has been developed into a leading player in all its target markets -today, the company operates in the Baltic states and Russia, but also in Finland and Sweden. The company is mostly known for its highly valued and appreciated brands in the ice cream market, the chilled fish products and the frozen goods markets.

The flagship brands of AS Premia Foods are Premia, Eriti Rammus, Heimon Gourmet, Väike Tom, Sakharny Rozhok, Baltiiskoje, Klasika, Maahärra, Viking, Natali, Buenol, etc.

Structure of the Premia Foods group of companies:



In addition to the above, the group has a 20% holding in AS Toidu- ja Fermentatsioonitehnoloogia Arenduskeskus (Competence Centre of Food and Fermentation Technology).



SUMMARY OF FINANCIAL RESULTS

Unaudited financial results of AS Premia Foods, 3rd quarter and 9 months, 2013

The financial results of Premia Foods during the 3rd quarter and 9 months, 2013, may be characterized by the increase of turnover for the third quarter in a row, considerably improved profitability and decreased operating costs. For the first time in the company's history, Premia reached organic quarterly increase of turnover by over 10% as the increase of turnover of the 3rd quarter was 13.8%. The EBIT in the 3rd quarter of 2013 increased 2.6 times, if compared to the same period of the previous year, reaching 2.7 million euro; in the summary of 9 months the corresponding figure was 3.1 million euro and the growth was 4.6 times. The net profit increased during the 3rd quarter of 2013, if compared to the same period of the previous year, by 1.9 times, reaching 2.1 million euro; in the summary of 9 months the net profit increased, if compared to the same period of the previous year, by 2.8 times, reaching 1.9 million euro.

The main financial results of the operations of the company during the reporting period are the following:

- The unaudited consolidated turnover of the 3rd quarter of 2013 of Premia Foods increased by 13.8%, i.e. 3.3 million euro, if compared to the results of the 3rd quarter of 2012, reaching 26.9 million euro. The unaudited consolidated turnover of 9 months of 2013 was 72.9 million euro, having increased on a yearly basis by 9.2%, i.e. 6.1 million euro. In the summary of 9 months of 2013, the turnover increased in all the business segments and target markets of Premia Foods.
- The company's gross profit of the 3rd quarter of 2013 was 7.1 million euro, remaining at the same level as during the same period of the previous year. In the summary of 9 months of 2013, Premia earned a gross profit of 18.8 million euro, which is 0.4 million euro less than the result of the same period of the previous year, whereas the main reason thereof is the decreased gross margin of the fish business segment. During the 3rd quarter of 2013, the ice cream business segment and the frozen goods business segment earned 0.5 million euro more gross profit, if compared to the results of the previous year; in the summary of 9 months the referred business segments earned 1.6 million more gross profit, if compared to the 9 months of 2012.
- Premia's EBITDA of the 3rd quarter of 2013 was 3.3 million euro, exceeding the result of the previous year by 1.8 times. In the summary of 9 months of 2013, the EBITDA was 5.0 million euro, exceeding the result of the previous year by 1.6 times. The EBITDA increased in the summary of 9 months of 2013 in all the business segments, the largest contribution came from the ice cream business segment.
- The positive impact of livestock revaluation on the operating profit of the company during the 3rd quarter was 1.3 million euro, if compared to the previous year; in the summary of 9 months of 2013, the positive impact on the operating profit was 2.4 million euro.
- The EBIT in the 3rd quarter of 2013 was 2.7 million euro, exceeding the result of the previous year by 2.6 times. In the summary of 9 months, the EBIT was 3.1 million euro, which exceeds the result of the previous year by 4.6 times. Also the operating profit improved during the 9 months of 2013 in all the business segments, the largest increase here came once again from the ice cream business segment.
- The net profit of the 3rd quarter of 2013 was 2.1 million euro, exceeding the result of the previous year by 1.9 times. In the summary of 9 months of 2013, Premia earned a net profit of 1.9 million euro, exceeding the result of the previous year by 2.8 times.
- The operating expense ratio decreased during the 3rd quarter by 4.6 percentage points, if compared to the same period of 2012, and in the summary of 9 months by 2.8 percentage points. In total, the operating expenses, on an annual basis, decreased during the 3rd quarter of 2013 by 0.4 million euro, in the summary of 9 months by 0.5 million euro.



Fish and fish products business segment

The turnover of the **fish and fish products business segment** achieved during the 3rd quarter the fastest growth of the last two years, increasing by 28.4%, i.e. 2.1 million euro, if compared to the same period of the previous year. The turnover growth came mainly from the HoReCa sector. In the summary of 9 months of 2013, the turnover of the fish business segment increased by 9.9%, i.e. 2.4 million euro, if compared to the same period of the previous year.

The proportion of the fish and fish products business segment in the turnover of 9 months of 2013 of Premia Foods was 36.4% which has remained at the same level, if compared to the same period of the previous year. The production volume of the fish products increased in the 3rd quarter of 2013 by 26.0% and by 6.0% in the summary of 9 months.

Similarly to the 1st half of the year, the prices of raw fish remained, during the 3rd quarter of 2013, at a considerably higher level, if compared to the level of 2012. The market price of salmon was, in the summary of 9 months of 2013, higher by 49.1% and the price of rainbow trout was higher by 28.9%, if compared to the price level of the previous year¹, whereas during the same period Premia lost only 10 percentage points in gross margin.

The main target market of the fish business segment is Finland. Due to the local market practice and peculiarities thereof, significant changes in the prices of raw fish can be transferred into the retail prices within 4-6 months as from notification about price changes and, as the prices of raw fish continued to increase during the 3rd quarter 2013, the positive impact of the price changes willbecome evident during the 4th quarter of 2013. Due to the continuously high price of raw fish, the EBITDA from operations decreased during the 3rd quarter of 2013 by 0.6 million euro and, in the summary of 9 months, by 2.0 million euro, if compared to the same periods of the previous year.

Premia has partially hedged the risk of the world market price fluctuations through vertical integration. If the world market price of raw fish increases, the value of the fish breed in Premia's fish farms increases as well, and that results in a positive impact of revaluation of livestock in the company's financial results. The positive impact of the livestock revaluation on the

EBITDA of and the operating profit of the company in the 3rd quarter of 2013 was 1.3 million euro, if compared to the previous year, and 2.4 million euro in the summary of 9 months. The operating profit of the business segment of 9 months increased by 0.5 million euro, if compared to the same period of the previous year.



Ice cream business segment

In the summary of 9 months of 2013, the turnover of **the ice cream business segment** increased by 1.6 million euro, i.e. 6.6%, if compared to the same period of the previous year. During the 3rd quarter of 2013, the turnover of this business segment increased by 0.3 million euro, i.e. 3.3%, if compared to the 3rd quarter of 2012. The turnover of the ice cream business segment increased during the peak season, i.e. the 2nd and the 3rd quarter, by 1.8 million euro, i.e. 8.5%, if compared to previous year. The greatest monetary increase in the summary of 9 months of 2013 came from Estonia, if compared to the same period of 2012, where the turnover was higher by 1.0 million euro, i.e. 12.2%, if compared to the same period of 2012. Latvia followed with the increase of 0.4 million euro, i.e. 12.4%. The good results of the ice cream business segment resulted from the successful novelty products in all the target markets, strong marketing and sales campaigns and favourable weather conditions.

The proportion of the ice cream business segment in the total turnover of 9 months of 2013 of Premia Foods was 35.7%. The production volume of the ice cream business, in summary of 9 months of 2013, remained at the same level (+0.1%), if compared to the 9 months of 2012.

The gross margin of the ice cream business segment remained during the 3rd quarter at the level of the 2nd quarter and, similarly to the previous quarters, continued to increase on an annual comparison. The gross margin increased in the summary of 9 months by 1.8 percentage points reaching 46%, if compared to the previous year. The company earned a gross profit which was, in the 3rd quarter of 2013, higher by 0.3 million euro, i.e. 7.4%, and in the summary of 9 months higher by 1.2 million euro, i.e. 11.1%, if compared to the previous year.

The EBITDA from operations of the ice cream business segment increased during the 3rd quarter of 2013 by 0.6 million euro, i.e. 40.8%, and by 1.2 million euro, i.e. 39.1% in the summary of 9 months, if compared to the same periods of 2012. The operating profit of the business segment increased by respectively 0.7 million euro, i.e. 58.5%, and by 1.4 million euro, i.e. 65.4%.

Premia continues in the 3rd quarter as the market leader of the Baltic ice cream market with the monetary market share of 23%, having increased its market share by 1 percentage point, if compared to the same period of the previous year. As a result of the exceptionally long and warm summer, the competition in the market was very intense, there were more novelty products and marketing campaigns than ever before and the desire of all market participants to seize additional market share was well recognisable. The competition between strong trademarks was, among other things, a reason why the market share of private labels has somewhat decreased, if compared to the 3rd quarter of 2012. Another important trend shows the increase of the market share of Ingman/Unilever in all the Baltic markets which is based on, among other things, massive advertising campaigns in mass media and discount campaigns in retail market. Premia focused in all the Baltic states on strengthening of its flagship brands through intensive product development and through advertising and sales campaigns which were focused on efficiency. A successful combination of these three resulted in the increase of market share in all Premia'starget markets.

Frozen goods business segment

The turnover of the frozen goods business segment continued to increase during the third quarter, increasing on an annual basis by 11.3%, i.e. 0.6 million euro. In the summary of 9 months of 2013, the increase of the business segment on an annual basis was 9.4%, i.e. 1.6 million euro. The turnover of the frozen goods increased the most in Lithuania in the summary of 9 months, i.e. by 0.9 million euro, Latvia followed with the increase of 0.6 million euro. The proportion of the turnover of 9 months of the frozen goods in the total turnover of 9 months of 2013 of Premia Foods was 24.8%, remaining at the same level as during the same period of the previous year.

The gross profit of the frozen goods business segment of the 3rd quarter of 2013 increased by 0.1 million euro, i.e. 11.4%, if compared to the result of the same period of 2012. In the summary of 9 months of 2013, the gross profit of the frozen goods business segment increased by 0.4 million euro, i.e. 11.1%, if compared to the comparable period of 2012. The gross margin has, throughout the quarters and also in the summary of 9 months, remained at the same level as during the previous year. The EBITDA from operations of the frozen goods business segment increased in the summary of 9 months by 0.1 million euro, if compared to the respective result of 2012.

In the summary of 9 months of 2013, the turnover of Premia has increased in all its target markets. The greatest increase in turnover came from Finland, where the increase was 2.2 million euro, if compared to the previous year. Estonia followed with the increase in turnover





of 1.5 million euro and Latvia came third with the increase in turnover of 1.3 million euro. The proportion of the Baltics in the turnover of 9 months of 2012 of Premia Foods was 57.4%.

COST ANALYSIS

The operating expense ratio decreased during the 3rd quarter of 2013 by 4.6 percentage points and in the summary of 9 months of 2013 by 2.8 percentage points, if compared to the previous year. Despite the rapid growth in turnover during the nine months of 2013, the operating expenses have decreased by 0.5 million euro, i.e. 2.6%, if compared to the same period of the previous year.

In the summary of 9 months of 2013, the marketing costs increased by 0.8 million euro, if compared to the same period of 2012, and it resulted mainly from increased media prices and the increased competition in all business segments and in all target markets. The logistics costs also increased by 0.6 million euro during the same period, the reason thereof was mainly the increase in turnover and the increase of fuel prices.


The cost of goods sold increased during the 9 months of 2013 by 6.6 million euro, if compared to the previous year, which mainly resulted from the increased turnover and rapidly increased prices of raw fish.

The EBITDA from operations of the 9 months of 2013, i.e. the operating profit before market price driven revaluation of livestock, one-off income and expenses and amortisation expenses, was 4.1 million euro which is by 0.7 million euro less than during 2012.

The EBITDA of the 3rd quarter of 2013 was 3.3 million euro, exceeding the result of the previous year by 1.8 times. In the summary of 9 months of 2013, the EBITDA was 5.0 million euro, exceeding the result of the previous year by 1.6 times.

During the nine months of 2013 there were one-off expenses in the amount of 218 thousand euro and during the same period of 2012 in the amount of 347 thousand euro.

The increase of the EBIT during the 3rd quarter of 2013 was 1.6 million euro and, in the summary of 9 months, 2.4 million euro, if compared to the previous year. The increase of the EBIT in the 3rd quarter resulted from the increased profitability of the ice cream business segment and from the profit from revaluation of livestock. In the summary of 9 months of 2013, all the business segments of Premia contributed to the increase of the EBIT.



The company's net profit of the 3rd quarter of 2013 was 2.1 million euro which is 1.0 million euro, i.e. 1.9 times, better than the results of the comparable period. The net profit of the first nine months of 2013 increased within a year by 1.2 million euro, i.e. by 2.7 times, reaching 1.9 million euro.

As at 30.09.2013, of all Premia's biological assets, 91% is comprised of rainbow trout and 9% of whitefish breed in the Finnish and Swedish fish farms. The comparable price of rainbow trout at the end of the 3rd quarter was higher by 34%, if compared to the previous year.

The profit arising from the revaluation of livestock during the 9 months of 2013 was higher by 2.4 million euro, if compared to the result of the same period in 2012.

FINANCIAL POSITION

The financial position of the company is continuously solid and the financial risk low.

The cash flow from operations during the first 9 months of 2013 was 1.8 million euro (2.8 million euro during the same period of 2012). The cash flow from operations was mainly influenced by the increase of biological assets. The livestock increased within 9 months by 643 tons, if compared to the previous year, which resulted in the decrease of the cash flow from operations by 3.7 million euro.

The level of net debt as at the balance sheet date was 14.6 million euro (on 30.09.2012 the respective figure was 10.9 million euro). Financial leverage, i.e. the proportion of net debt in the total capitalisation, was 28% (on 30.09.12, the respective ratio was 23%). In the 4th quarter of 2012, the company assumed an additional long term loan in the amount of 3.9 million euro with the purpose of making payments to the shareholders in connection with the share capital decrease. Therefore, while analysing the liquidity and solvency ratios of the company, the impact of the restructuring the debt and the equity, which occurred in the 4th quarter of 2012.

Net debt to EBITDA as at 30.09.13was 3.31 (30.09.12: 2.06). In case of elimination of the aforesaid equity distributions, the respective comparable ratio would have been 2.43 as at 30.09.13. The liquidity ratio demonstrating short-term solvency was as at 30.09.13 1.86 (30.09.12: 1.55). The proportion of equity in the balance sheet total was 58% (30.06.12: 57%) and the company had working capital in the amount of 13.1 million euro (30.09.12: 9.7 million euro).

BALANCE SHEET ANALYSIS

The consolidated balance sheet total of Premia Foods was as at 30.09.13 66.1 million euro, having increased by 0.6 million euro, i.e. 1.0%, per year.

The company's current assets amounted to 28.3 million euro and the balance of cash and bank accounts was 1.3 million euro. As at 30.09.13, the company had undrawn overdraft facility limit in the amount of 2.0 million euro.

Accounts receivable and prepayments amounted to 9.1 million euro and 92% of the accounts receivable and prepayments were trade receivables. Comparing to the previous year, the accounts receivable and prepayments increased by 7.9%, i.e. 0.7 million euro. The increase of receivables has resulted from the 13.8% increase of turnover in the 3rd quarter.

Comparing to the previous year, inventories and livestock combined have increased by 3.9%, i.e. 0.7 million euro.

Accounts payable and prepayments have, if compared to 30.09.12, decreased by 12%, i.e. by 3.6 million euro. As at 30.09.2012 accounts payable and prepayments included liability to shareholders arising from the share capital reduction in the total amount of 3.9 million euro The liabilities in total have decreased by 1.7%, i.e. by 0.5 million euro, amounting to 27.9 million euro.

The equity of Premia Foods was as at 30.09.13 38.2 million euro.

INVESTMENTS

During 9 months of 2013, the expenditures into Premia Foods' tangible and intangible assets were 2,154 thousand euro (2012 9 months: 1,765 thousand euro). 774 thousand euro from that amount was invested in modernizing the production lines in the ice cream factory located in Tallinn and to increase production efficiency, also for innovation.



PERSONNEL

By the end of the 3rd quarter of 2013, the number of employees has increased by 3 people, if compared to the same period of the previous year, whereas the average number of employeesduring the 3rd quarter was smaller by 15 people, if compared to the same period of previous year. The decrease of the average number of employees resulted mainly from the reorganizations carried out in Russia and in Lithuania which cover the increased labour needs in the Estonian fish and ice cream production units resulting from the increased production volumes during the third quarter.

The payroll expenses have increased during the 3rd quarter of 2013 by 4.8%, if compared to the previous year. In the summary of 9 months, the payroll expenses have increased by 5.7%.



MANAGEMENT AND MANAGING BODIES

The highest managing body of a public limited company (in Estonian: *aktsiaselts*) is the general meeting of shareholders. According to law, the general meetings of shareholders are ordinary and extraordinary.

Pursuant to law, Supervisory Board of public limited company is a surveillance body that is responsible for planning the activities of the company, organizing management thereof and supervising the activities of Management Board. In accordance with the Articles of Association of AS Premia Foods, there are three to seven members of the Supervisory Board elected by the general meeting of shareholders for the term of 5 years.

As at today, the Supervisory Board of AS Premia Foods comprises of Lauri Kustaa Äimä (as from incorporation), Indrek Kasela (as from incorporation), Aavo Kokk (elected on 5 May 2009), Harvey Sawikin (elected on 5 May 2009), Jaakko Karo (elected on 17 August 2009), Arko Kadajane (elected on 29 May 2012) and Kuldar Leis (elected on 29 May 2013).

Management Board is the representative body of public limited company being responsible for everyday management of the company. According to the Articles of Association of AS Premia Foods, the Management Board comprises of one to four members elected for the term of 3 years.

As at today, the everyday business activities of AS Premia Foods are carried out by the members of Management Board Katre Kõvask (elected on 9 June 2009), Silver Kaur (elected on 9 June 2009) and Erik Haavamäe (elected on 29 May 2013).



The meeting of Supervisory Board appointed Katre Kõvask as the chairman of Management Board starting from 15 May 2013.

Notes to the Interim Report

Note 1. Summary of material accounting policies

AS Premia Foods is a company registered in Estonia. The interim report as at 30September2013 contains AS Premia Foods (hereinafter the Parent Company) and its subsidiaries Saaremere Kala AS in Estonia, AB Premia KPC in Lithuania, OOO Khladokombinat No 1 and OOO Khladomagija in Russia and companies belonging into the group – OÜ Vettel, OÜ GourmetHouse and AS Premia Tallinna Külmhoone in Estonia, Heimon Kala OY in Finland, Överumans Fisk Ab in Sweden, AS Premia FFL in Latvia (hereinafter also the Group). The Group has a holding in an affiliated entity Toidu- ja Fermentatsioonitehnoloogia Arenduskeskus (Competence Center of Food and Fermentation Technology; CCFFT). AS Premia Foods is listed on the NASDAQ OMX Tallinn Stock Exchange since 5 May 2010.

The Group's consolidated audited annual report for the financial year that ended on 31 December 2012 is available at the Parent Company's location at Betooni 4, Tallinn and on the Parent Company's website www.premiafoods.eu.

Confirmation of Compliance

The current unaudited consolidated interim report complies with the requirements of international accounting standards IAS 34 "Interim Financial Reporting" on condensed interim financial statements.

While preparing the interim report at hand, the same accounting principles as in the annual report for the financial year ended on 31.12.2012 have been applied. The report does not hold all the information that must be presented in a complete annual report so it should be read together with the Parent Company's audited consolidated annual report for the financial year that ended on 31 December 2012, which is in compliance with international finance reporting standards (IFRS) as adopted by the European Union.

The Management Board approved the publication of this condensed unaudited consolidated interim report on 12November 2013

In the opinion of the management, this interim report for 3rd quarter and 9 months 2013 of AS Premia Foods presents correctly and fairly the financial results of the Group as a going concern. Current interim report is neither audited nor reviewed by auditors in any other way and contains only the consolidated reports of the Group.

Basis of Preparation

The functional currency is euro. The consolidated interim report is presented in thousands of euro and all numerical indicators have been rounded to thousand, if not indicated otherwise. In the report, thousand euro is indicated as an abbreviation EUR '000.

Use of Assessments

In preparing the interim report, the Management Board must form opinions, give assessments and make decisions that affect the application of accounting principles and the values of assets and liabilities, incomes and expenses. Actual results may differ from the assessments.

The same assessments of the management that were used to prepare the consolidated annual report for the financial year that ended on 31 December 2012 were used to prepare this condensed consolidated interim report.

Effective interest rates are very close to nominal interest rates. Additionally to the collateral granted for the securing of loans, the company has issued a bank guarantee in the amount of 624 thousand euro to the lessor of Betooni 4 for covering the lease payments and established a mortgage in favour of the Finnish Customs Board for securing the 30-days payment term in the amount of 84 thousand euro.

The company has hedged the risk arising from variable interest rate of the long-term investment loan by executing two transactions of Interest Rate Swap with amortization and fixed the 3 months EURIBOR at the level of 0.799% and 0.785% until 17.07.17. The mark-to-market value of these financial instruments as at the balance sheet date 30.09.13 was -29 thousand euro and the impact on the income statement as a finance income was 17 thousand euro.

A relatively high integration level exists between reporting segments of ice cream and frozen goods products, which involves joint marketing, sales and marketing services.

The Management Board of the Parent Company assesses the results of business segments on the basis of external revenue and operating profit figures. The management also monitors secondary measures – EBITDA (profit before financial, tax expenses and depreciation, amortisation and impairment of non-current assets) and EBITDA from operations (EBITDA before fair value adjustments on biological assets and one-off expenses). These financial indicators are presented in the tables below.

Income and expenses of business segments include income and expenses directly generated by the segment. The integrated expenses (marketing and sales expenses, general and administrative expenses and other operating income and expenses) are allocated between the segments of ice cream and frozen goods according to the percentages of unconsolidated revenues of the respective segments. The expenses of the Parent Company (general management expenses of the Group) and amortisation of intangible non-current assets are not allocated to segments.

Note 12. Contingent Liabilities and Assets

Compensation Claim against Swedish Board of Agriculture

On 31 July 2013, Överumans Fisk AB, the fully owned subsidiary of AS Premia Foods, filed a claim of compensation of damage and loss of profit against the Swedish Board of Agriculture (Jordbruksverket) in connection with the on-going administrative proceedings initiated against Överumans Fisk AB in May 2012 resulting in the destruction of 17 tons of fish fingerlings. The total amount of damage and loss of profit claimed to be compensated is up to approximately SEK 25,486,867.70 (approximately 3 million euro). The ground for claiming the compensation is the fact that the measures applied in respect of the fish farms operated by Överumans Fisk AB have been more severe if compared to the other fish farms in the same region and therefore disproportional. Due to the extraordinary nature of these proceedings, it is difficult to estimate the final result of the compensation claim and the exact time of adopting relevant decision of the Swedish Board of Agriculture. Aforementioned claim has not been recorded in the company's balance sheet as of 30 September 2013.
