
RESULTS FOR THE TWELVE MONTHS OF 2008

TEO LT, AB GROUP



HIGHLIGHTS OF 12 MONTHS OF 2008

- Revenue up by LTL 33 million or 4.1% (y-o-y)
- Operating expenses up by LTL 35 million or 7.8% (y-o-y)
- EBITDA declined by LTL 3 million or 0.9% (y-o-y)
- Net profit eased by LTL 3 million or 1.8% (y-o-y)
- Record growth of DVB-T service users' number
- Rapid growth of fiber optic (FTTH) connections
- Number of IPTV users increased by 2.3 times
- New features and new channels offered to IPTV users
- Decreased networks' interconnection tariffs
- Capital investments amounted to LTL 180 million






TEO GROUP

- In December 2008, AB Nacionaline Skaitmenine Televizija was merged into TEO LT, AB
- In December 2008, TEO sold its stake in UAB Voicecom (NMT-450 licence) and acquired UAB Verslo Investicijos






VOICE TELEPHONY SERVICES

- Net number of telephone lines during 2008 decrease by 21.1 thousand
- In February 2008, TEO terminated provision of temporary disconnected telephone line with incoming calls service
- From February 2008, number of active lines increased by almost 35 thousand
- In August, TEO reduced tariffs for networks' interconnection and calls to the networks of other Lithuanian operators

Number of main lines (thou.)









DIGITAL TERRESTRIAL TELEVISION

- Digital terrestrial television (DVB-T) service Digital GALA (Skaitmeninė GALA) was launched in March 2008
- 38 TV channels for LTL 29 per month
- Service is available almost all over the Lithuania
- TEO operates 2 networks of DVB-T transmitters
- On 29 October 2012 Lithuania will switch from analogue to digital TV broadcasting

Number of DVB-T users






INTERNET TELEVISION

- Launched in October 2006 as GALA, in 2008 was renamed into Interactive GALA (Interaktyvioji GALA)
- More than 70 TV channels in main and additional packages
- In October to main package were added FoxLife, FoxCrime and NBA TV, to news package
 CNBC and to children's – KiKa
- In November launched a new feature – GALA Karaoke



FIXED VOICE TELEPHONY MARKET IN LITHUANIA (9 MONTHS OF 2008)

Total revenue: LTL 300 million
 (2007: LTL 309 million)

- 47 companies are providing fixed voice services: 28 provide national and international calls, 14 only international, 5 only wholesales (transit)
- 31 companies are using IP network, 17 of them CATV networks
- Number of alternative operators subscribers: 52.8 thousand or 6.4% of total subscribers' number
- TEO market share (Q3 2008) in terms of:
 - total number of customers: 93.6%
 - total traffic: 96.0%
 - revenue from local calls: 99.4%
 - revenue from domestic long distance calls: 89.2%
 - revenue from international calls: 77.8%



Q3 2008 revenue by service providers





Breakdown of revenue for 12 months of 2008







Breakdown of expenses for 12 months of 2008




- In January 2008, TEO acquired Nacionalinė Skaitmeninė Televizija for LTL 16.4 million
- Capital investments during 2008 amounted to LTL 180.4 million
- 70% of investments went to network, 14% for IT systems, 11% for buildings' renovation, 4% for transport and 1% for other investments
- In May 2008 dividends of LTL 194 million for the year 2007 were paid out



DIVIDEND PAYOUT

- Following the Lithuanian Law on Company dividends should be paid from the Parent company's retained earnings
- TEO LT, AB retained earnings 2008:
 LTL 185 million
- Consolidated TEO Group retained earnings 2008: LTL 260 million
- In March 2009 the Board should approved audited financial results for the year 2008 and present a profit allocation proposal to the Annual General Meeting of Shareholders


